## **New Business:**

• Same Day Registration (SDR) (S 24.2-420.1 Effective October 1. 2022) Extended time for certain persons to register in person A. Notwithstanding the provisions of S 24.2-416, any person who is qualified to register to vote shall be entitled to register in person up to and including the day of the election at the office of the general registrar in the locality in which such person resides or at the polling place for the precinct in which such person resides). Donna attended a webinar on August 31, 2022 and reported on the SDR procedure. Voter will fill out the SDR form on the day of election and would vote provisional and the Officer of Election will put the provisional vote in bag 1A and at the canvass the Electoral Board will determine if their vote will be valid to count. SDR protocol will be included in the Officers of Election training.

## **General Registrars Report:**

- Eric and Donna are working on updating the training slides for the November elections for the
  Officers of Election. Training date is set for October 12, 2022 at 6:00 p.m. at The BC Historical
  meeting room.
- Early voting will begin September 23, 2022. Donna will be using a receipt printer for early voting. Donna will check in the voter and give them a ballot and then keep the receipt for her records.
- Highland Computers are installing cameras in Donna's office. Work is being done to move Donna's office in the next room.
- Lisa Compton will be the chief at Fairview Precinct for the November election. All other precincts are all staffed for November.
